Mrs. Smithyman called for a reading of the minutes of the January 20, 2025, BoD meeting. A motion to accept the minutes was made by Mr. Tarr and seconded by Mrs. Baker; the motion passed unanimously.

Treasurer's report - Graceann Ruven:

In response to a question regarding the total amount in the treasury, Mrs. Ruven reported that there was a total of \$11,960.81. Expenses for the annual meeting were briefly discussed and will be examined more closely for next year's budget. A motion to accept the Treasurer's report was made by Mrs. Baker and seconded by Mrs. Perusse; the motion passed unanimously.

Mrs. Smithyman reported that no one has volunteered to take charge of the event. If no one volunteers soon, the event will be canceled.

Boulevard Committee Report - Dick Tarr:

Mr. Tarr advised that there is no report; "everything is the same."

Architectural Control Committee - Dianne Baker/Director-ACC Liaison:

Mrs. Baker reported that at the January ACC Meeting there was no old business. Regarding new business, a resident was asked to take down a political sign and he complied. Nine approvals were given this month. There was a brief discussion regarding metal roofs which will be continued at future ACC Meetings.

Old Business – Dick Tarr:

Mr. Tarr, Chairperson of the Committee appointed to meet with the BoD of the Caloosa Golf and Country Club, stated that the Committee is making progress in planning their approach to the meeting.


New Business- Merlene Moll Smithyman:


